



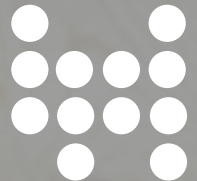
Who we are

Our future objective is to provide scholarships, international exchange programmes, and work experience to NRG students and graduates.

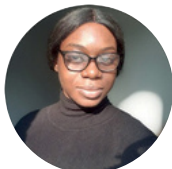
